Machine Readable Broker Research – Additional Brokers

In September 2021, we introduced a machine-readable version of Exane BNP Paribas research reports through Xpressfeed and Snowflake. Research reports from additional brokers will be coming soon.

With these new textual data sources, you'll be able to link to S&P Capital IQ Estimates to perform both quantitative and NLP analysis on the same estimate report. Similar to our existing machine-readable company filings, broker analytical reports are broken down into identifiable sections, with extraneous information such as page numbers removed to streamline your textual data analysis. Note that broker research will require a separate agreement with each broker.

Point-In-Time Corporate Hierarchy

We are planning to release a point-in-time version of the ultimate parent cross reference package containing links between an entity and its ultimate parent, on a historical and on-going basis. You will be able to identify when a parent-to-subsidiary relationship was established or changed.

Non-English Filings in Machine Readable Filings

Non-English language filings will soon be added to our Machine Readable Filings offering. As with the English language filing types, the non-English filings provide:

- basic metadata in the filing
- raw text in the filing broken down into the sections identified in the document

Compustat® Fundamentals

We plan to add the following three new credit loss data items to existing Snapshot packages:

- Provision for Credit Losses on Loans
- Provision for Credit Losses on Securities
- Community Bank Leverage Ratio (CBLR)

In the aftermath of the 2008/2009 recession, FASB initiated an accounting standard to change the way losses are incurred on loans. This accounting standard changes the way banks and credit unions record losses from when it becomes probable that a loss will occur, to instead having a forward-looking impairment approach which records expected losses on the first day of origination or acquisition—a Current Expected Credit Loss model (CECL).

While loans are the main focus, the accounting standard has implications for all types of financial assets and the reporting of disclosures.

GICS Consultation Extended

S&P Dow Jones Indices (S&P DJI), a leading provider of financial market indices, and MSCI Inc. (MSCI), a leading provider of research-based indexes and analytics have decided to consult with members of the investment community on potential changes to the GICS structure in 2022.

The review is intended to ensure that the GICS structure is reflective of today's markets and continues to be an accurate and complete industry framework.

The consultation, which began on October 18, 2021, has been extended to February 18, 2022. Any changes to the GICS structure are expected to be announced by March 2022, with an expected GICS Direct implementation date in March 2023. In addition, S&P Global and MSCI will provide proforma classifications for a select list of companies potentially impacted by the consultation with market capitalization above US \$2 billion no later than January 21, 2022. Please note that the proforma classifications should only be used for preliminary analysis and should not be considered as final classifications even if the proposals are ultimately adopted. This consultation may or may not result in any changes to the GICS structure.

Key highlights of this consultation are potential changes to the classification of renewable energy companies and retailers within the GICS framework. In addition, the consultation covers potential changes for Data Processing & Outsourced Services, Banks and Thrifts & Mortgage Finance, REITs, Transportation, and an update in the GICS definition for cannabis.

Blog: “Unlocking the Full Potential of Earnings Transcripts with Kensho NERD”

Most of the 3,500+ U.S.-based, publicly traded companies listed on major exchanges hold conference calls shortly after announcing quarterly earnings. The transcripts can be a rich source of information, often revealing insights not readily apparent in a company’s financial reports. However, the volume of information can be overwhelming for any analyst that needs to follow a portfolio of companies. There are several challenges that make it difficult to zero in on relevant information. This blog discusses three of these challenges:

- Companies may be mentioned in numerous transcripts, not just their own
- Companies can have names that include commonly used words
- Companies are often referred to by acronyms, ticker symbols, or previously used names (when doing historical analysis)

To help make transcripts reviews easy and more insightful, the blog also introduces *Kensho Named Entity Recognition and Disambiguation on Transcripts (“NERD”)*, a cutting-edge machine-learning system that unlocks the full potential of textual data found in [S&P Global Market Intelligence’s Machine-Readable Transcripts](#). NERD identifies all companies that were discussed in any way in a transcript and where the mentions occurred. It then links the mentions to the appropriate S&P Capital IQ company ID, augmenting the textual data by making connections with other sources of structured knowledge for deeper insights, such as data provided through Xpressfeed and Snowflake.

Video: “Stock Price Prediction Using China Sentiment Analytics and the Marketplace Workbench”

Sophisticated technologies such as Natural Language Processing (NLP) and Optical Character Recognition (OCR) have been increasingly used to create textual sentiment indicators in order to gauge the financial health of companies. These technologies are especially helpful in markets such as China where there is a lack of reliable and timely financial data.

See how S&P Global Data Scientist, Andrew Bovey, used the China Sentiment Analytics dataset with the Marketplace Workbench to create textual sentiment indicators for stock price prediction in the Chinese market. In this video, we will preview:

- How to extract and break down the raw text (in simplified Chinese) from the financial disclosures section into sub-components for analysis
- Calculating sentiment scores at a section, article, and company level

- Potential causal relationships between Chinese stock price movements and their underlying sentiment data
- Whether or not the China Sentiment Analytics dataset can help us predict future values of a separate signal

Webinar Replay – Machine Readable Filings for Actionable Insights with Databricks

Companies change their business models over time to adapt to technological changes. As a result, traditional methods for classifying companies may not capture the changes in a company's underlying business functions.

S&P Global Product Management and Data Science teams collaborated with Databricks to create notebooks that leverage **S&P Global Textual Data** and **natural language processing (NLP)** to create value by learning the contextual meaning of words in company filings. The notebooks detect similarities among companies by analyzing the Business Overview section of 10-K filings, show how industries have evolved by looking at several companies' business narratives and seeing how they changed over a 10-year period, and analyze outliers—companies that might be classified in the wrong industry, as well as ones that have changed the most over time.

Service Advisory on log4j Software Library

As you may be aware, a Remote Code Execution (RCE) vulnerability (CVE-2021-44228) was identified in the log4j software library.

Protecting our customers' data is a top priority at S&P Global and our Cyber Security team continues to actively monitor this situation. S&P Global has been working diligently to implement layered security defenses to protect our systems as well as addressing the vulnerability on systems that potentially leverage the affected software package.

At this time, there is no information or evidence to suggest that S&P Global has been adversely impacted by this event. Additionally, we have not been notified of any adverse impact with our critical vendors. However, we remain vigilant and are proactively contacting our critical vendors.
