The onboarding documentation collected via Investor Onboarding may be custom configured on a legal entity-by-legal entity basis based on the fund requirements and investor profile.

It provides a better client onboarding experience and reduces the possibility of data discrepancies that trigger due diligence concerns and duplicate documentation requests. Our platform streamlines the investor experience with a white-labeled user interface and allows them easy access to their data across investments. Built-in tailored logic ensures investors only provide information relevant to their investor type (individual, entity, trust, etc) and their residences.



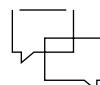
Increase Efficiency

For investors:

- Upload supporting documentation real-time in any file format.
- Permission third-party to complete, review or edit, and upload required information.
- Reuse information and documentation from previously completed subscriptions for new investment opportunities.
- View status of completed subscription in approval workflow process.
- Integration with DocuSign allows for easy digital signature and completion.

For managers and administrators:
