

**Trade:** Identifying characteristics of a trade. Examples: trade date, market, par/distressed, counterparties, effective date.



**Facility On-Hold:** Details surrounding any holds impacting trades. Examples: Date when the facility hold expires, date when the facility was put on hold.



**Credit/Facility:** Names and identifiers for credit and facility at trade-level. Examples: Credit and facility name, LXID, when issued date, currency.



**Settlement Date Selection:** Settlement date approval status for all parties including agent. Examples: Approval status and date selection for all parties.



**FM Setup:** Net payment details at subtrade level. Examples: Payment amount, currency, assignment fee detail.



**Client Reference:** Internal client reference numbers for parties and agents.



**Netted Totals:** Advanced trade details including netting, combined, multilat etc. Examples: Advanced trade type, list of subtrades involved in advanced trade.



**Signature Removal:** Detailed history of signature removal events for all settlement documents. Examples: Action performed date, action removed date, signatory name
