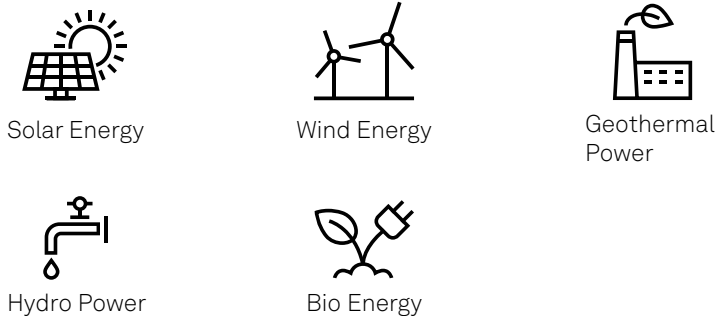
Transitioning to Cleaner and More Sustainable Energy

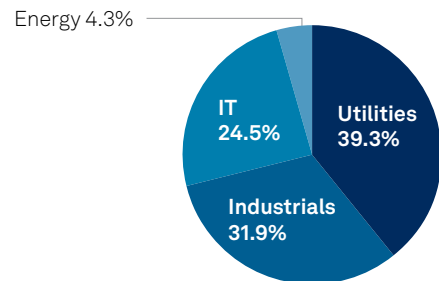

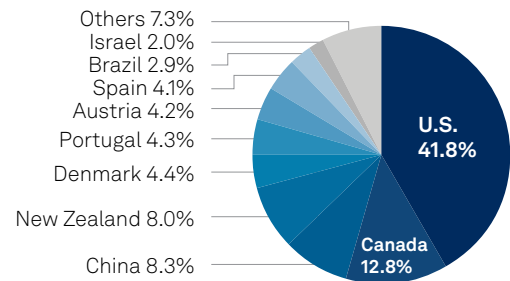
