AMSTERDAM, JANUARY 23, 2020: S&P Dow Jones Indices (“S&P DJI”) announces updates to the withholding tax rates for Argentina, Colombia and Ireland

The table below summarizes the changes.

Country	Tax Rate (%)

Colombia	7.5	10
Ireland	20	25
Argentina ¹	7	7

These changes will become effective prior to the market open on Monday, January 27, 2020.
