

S&P Euro 50 Equal Weight Index Reference Date Modification

AMSTERDAM, AUGUST 22, 2023: S&P Dow Jones Indices ("S&P DJI") announces a change to the methodology of the S&P Europe 350 Index Family.

S&P DJI is amending the rebalancing reference date for the S&P Euro 50 Equal Weight Index. The table below summarizes the change.

	Previous	Updated
Rebalancing Reference Date: S&P Euro 50 Equal Weight Index	The rebalancing reference date is the last business day of the prior month.	The rebalancing reference date is the third Friday of the prior month.

This change becomes effective on **Friday, September 1, 2023**, in conjunction with the pro-forma file delivery for the September rebalancing.

Please note that the S&P Europe 350 Index Family Methodology on S&P DJI's website is being updated to reflect this change.
