IHS Markit Benchmark Administration Limited Consultation on Certain iBoxx Custom Indices

LONDON, NOVEMBER 13, 2023: IHS Markit Benchmark Administration Limited ("IMBA UK") is conducting a consultation with market participants on potential changes to four iBoxx custom indices.

BACKGROUND & PROPOSAL

The four custom indices listed below are based on standard sub-indices from the iBoxx EUR Benchmark and iBoxx GBP Benchmark index families. For the custom index calculation, bond insertions and existing bonds follow the same prices as referred in the respective benchmark index.

The sub-indices and their respective weights are highlighted in the below table. In order to exclude issuers from the Oil & Gas industry and include bonds with 12 months or less to maturity, IMBA UK proposes to update the index methodologies according to the below details. The methodology update aims to enhance the precision and relevance of the indices, aligning them more closely with the evolving preferences and considerations of users.
