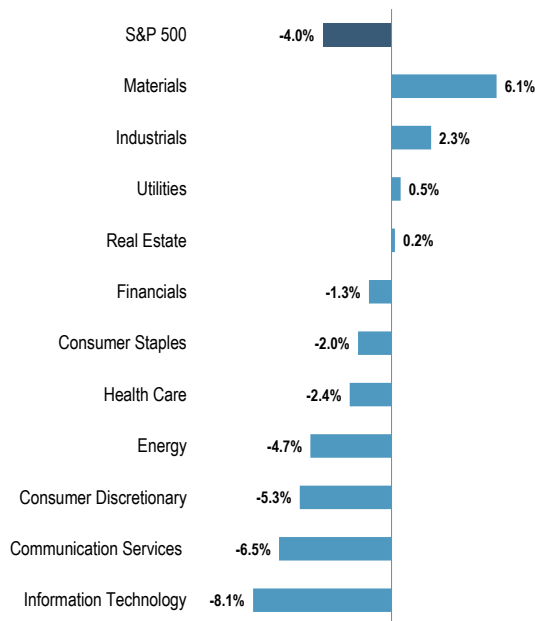

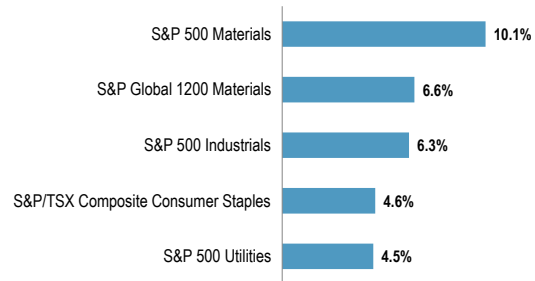

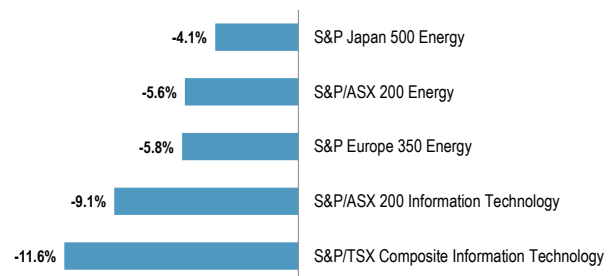
**S&P 500 Sectors - Total Return MTD**

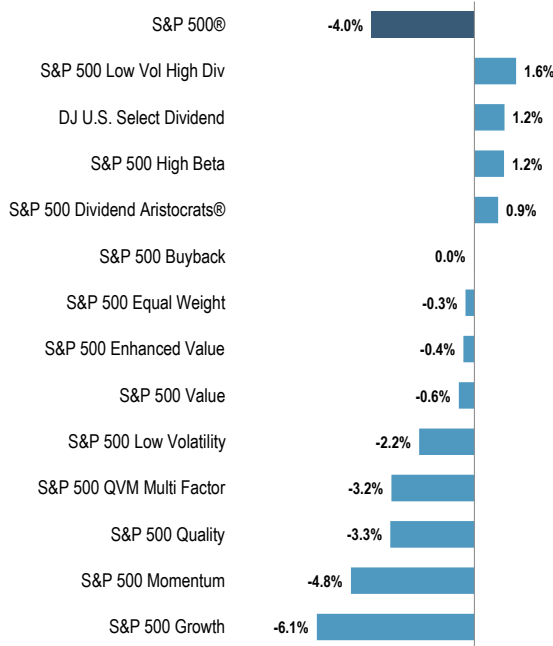

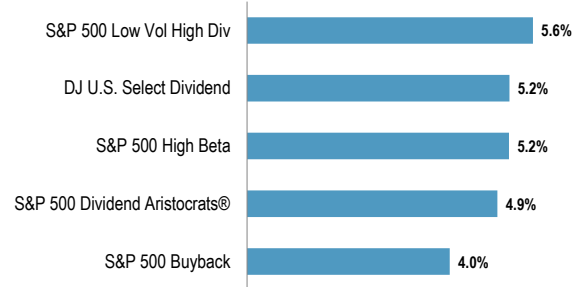

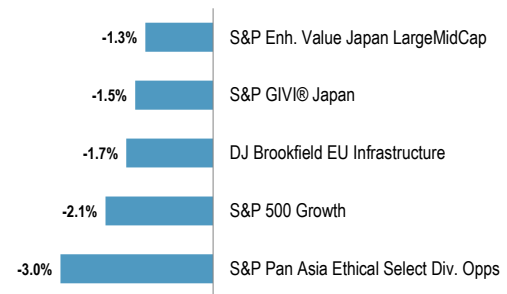
**U.S. Equity Factors - Total Return MTD**

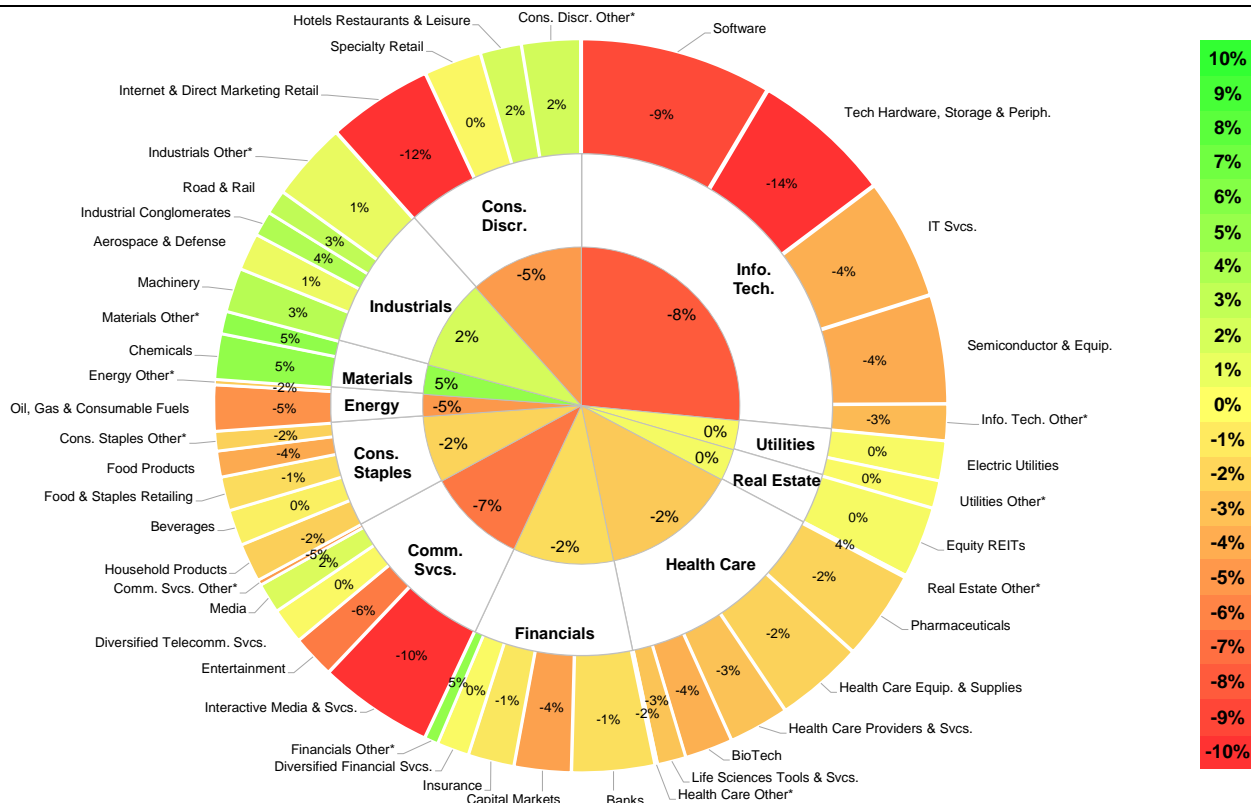

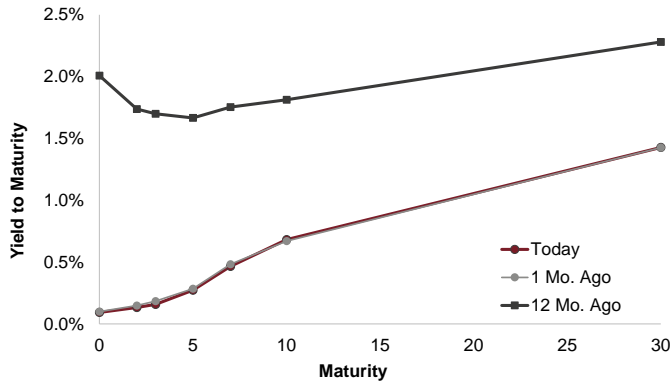

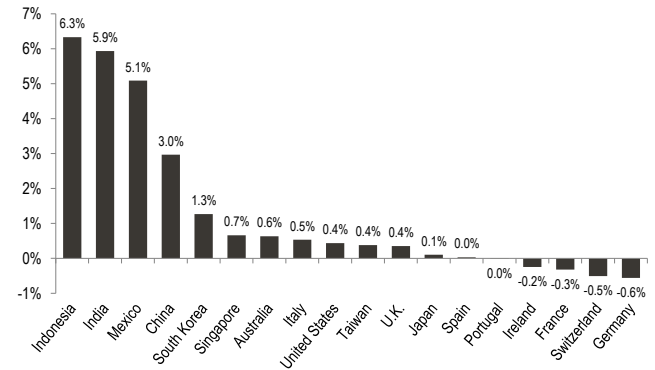

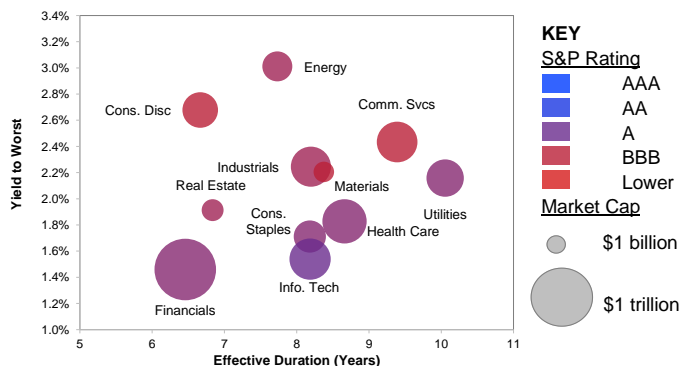

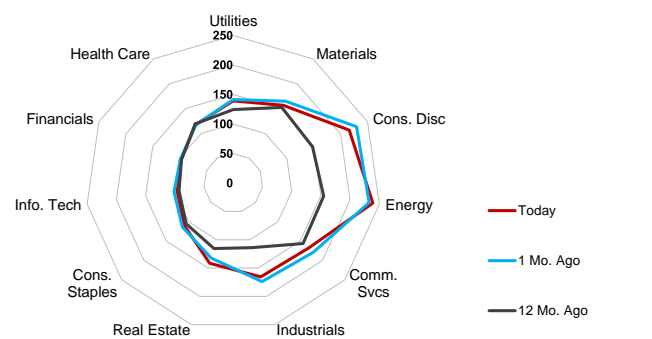
