


Dashboard: S&P 500® Options Strategy Indices June 30, 2025

Performance Summary

- The S&P 500 continued its positive trajectory into June, posting 4.96%. The index hit a record high amid calming tariff concerns, a positive labor market, moderating inflation and easing geopolitical tensions in the Middle East.
- All but one of the options strategy indices were up last month, with the S&P 500 Daily Covered Call Index TR (up 5.44%) outperforming the S&P 500 by 0.48% in June. The Cboe S&P 500 Risk Reversal Index is up 5.52% YTD, marginally outperforming the S&P 500 (up 5.50%) during this period.
- None of the options strategy indices have outperformed the S&P 500 over the last year, with the equity index up 13.63% during this period. However, several of these indices have posted high single-digit and low-double digit returns over this period.
