

**COMMENTARY**

- The S&P Kensho New Economies Composite had a challenging final quarter, but managed to end the year with a gain. The S&P Kensho New Economies Select fared worse, ending the year down 8%.
- Future Security continued its relative strength from the prior quarter and was the best performing sector in Q4 and for the year. Democratized Banking lagged, as a result of its exposure to Distributed Ledger, Alternative Finance, and Future Payments.
- Virtual Reality was the top performing subsector, followed by Autonomous Vehicles and Cyber Security. Laggards included Digital Communities, along with Alternative Finance and Distributed Ledger.
- S&P Kensho Moonshots ended 2021 on a weak note, down 15%, driven by poor performance within the Biotech space.

**BACKGROUND**

The S&P Kensho New Economies are a family of indices describing the industries and innovations of the Fourth Industrial Revolution. Rapid developments in artificial intelligence and robotics, coupled with exponential processing power and ubiquitous connectivity, are driving structural changes in the global economy, disrupting existing industries and forging new ones.

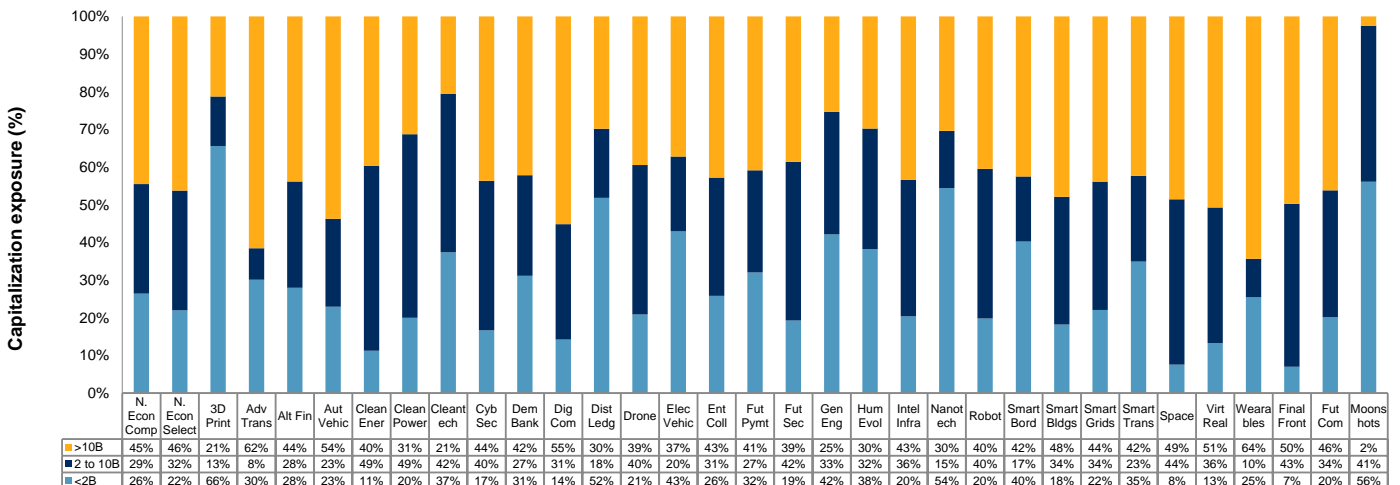
The S&P Kensho New Economies Composite Index is designed to measure the performance of companies involved in the New Economies 21st Century Sectors, including a dynamically adjusted list of companies drawn from all of the S&P Kensho Subsector Indices. The S&P Kensho New Economies Select Index measures a subset of the five best-performing subsector indices.

The S&P Kensho Moonshots Index is designed to measure the performance of 50 U.S.-listed companies with the highest Early-Stage Composite Innovation Score, subject to market capitalization and liquidity criteria, that produce the products and services shaping our future.

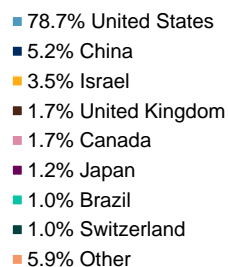

#### S&P Kensho New Economies Select

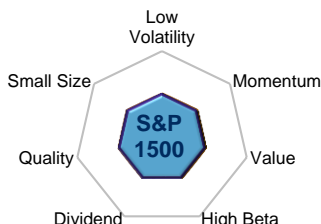

### KEY TO FACTOR SCORINGS FOR INDICES

#### Factor Definitions

Each constituent of the S&P 1500 index is provided with a factor "score" for each of Beta, Volatility, Momentum, Dividend, Size, Value and Quality.



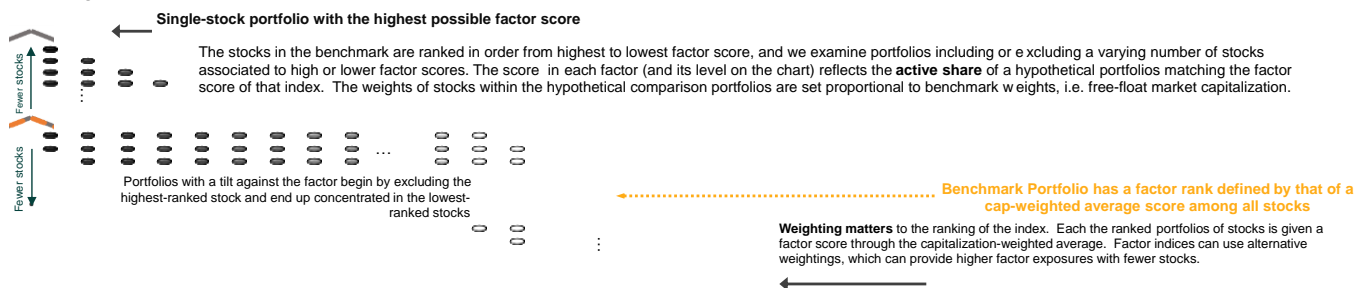
Factor	Measurement at single-stock level
<b>Volatility</b>	Trailing 12-month daily return volatility
<b>Momentum</b>	Twelve-month price change as of one month ago ("13 minus 1 momentum"), divided by the daily volatility during the twelve-month period that ended one month ago. For more details, see the S&P Momentum methodology
<b>Value</b>	The average of (normalized) earnings to price ratio, book to price ratio and sales to price ratio. For more details, see the S&P Value methodology.
<b>Beta</b>	Trailing 1 year beta of stock daily returns to the benchmark's return.
<b>Dividend</b>	Trailing 12-month dividend
<b>Quality</b>	The average of the (normalized) return on equity, the negative of the accruals ratio and the negative of the financial leverage ratio. For more details, see the S&P Quality methodology.
<b>Size</b>	Free-float market capitalization

#### Index Factor Ranking and Factor Diagram Scaling

##### Index Scores

Each index is provided a score in each factor from -100% to +100% based on how much of the total capitalization of the benchmark must be excluded in order to provide a portfolio of stocks with similar exposure to that factor. This is done by examining a ranked series of hypothetical cap-weighted portfolios, including or excluding an increasing number of the stocks with the highest or lowest scores. 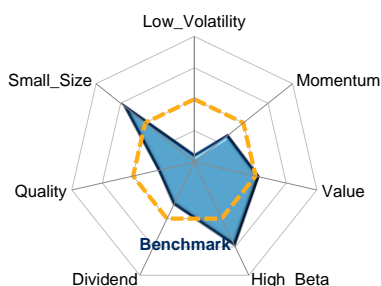
##### Factor Diagram Axis



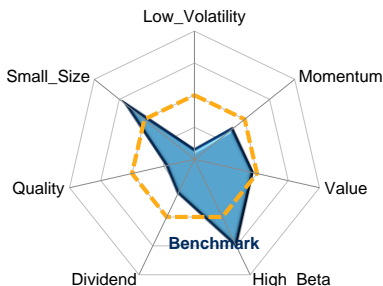

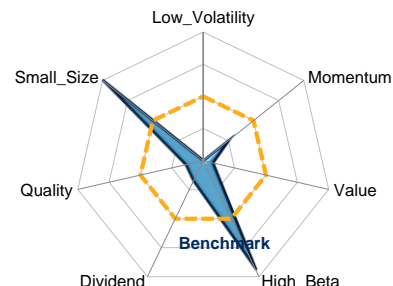

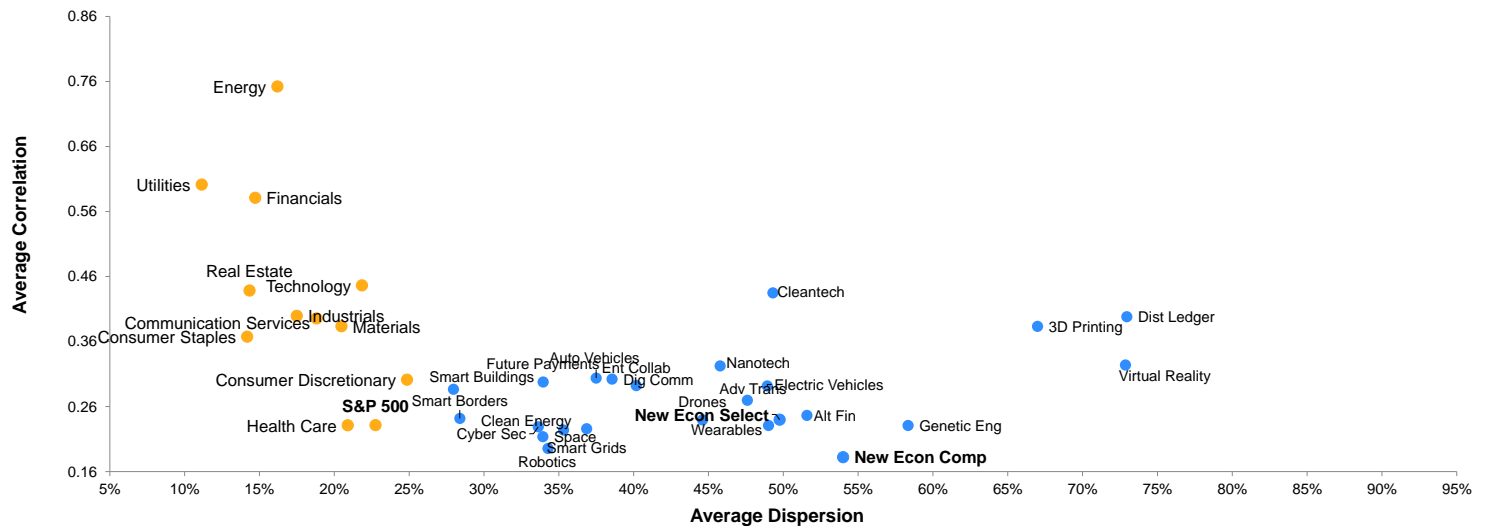
COMMENTARY

- Dispersion increased across most Kensho sectors and subsectors, with large increases for Virtual Reality and 3D Printing.
- Correlations increased across most Kensho sectors and subsectors, particularly in Wearables and Final Frontiers.

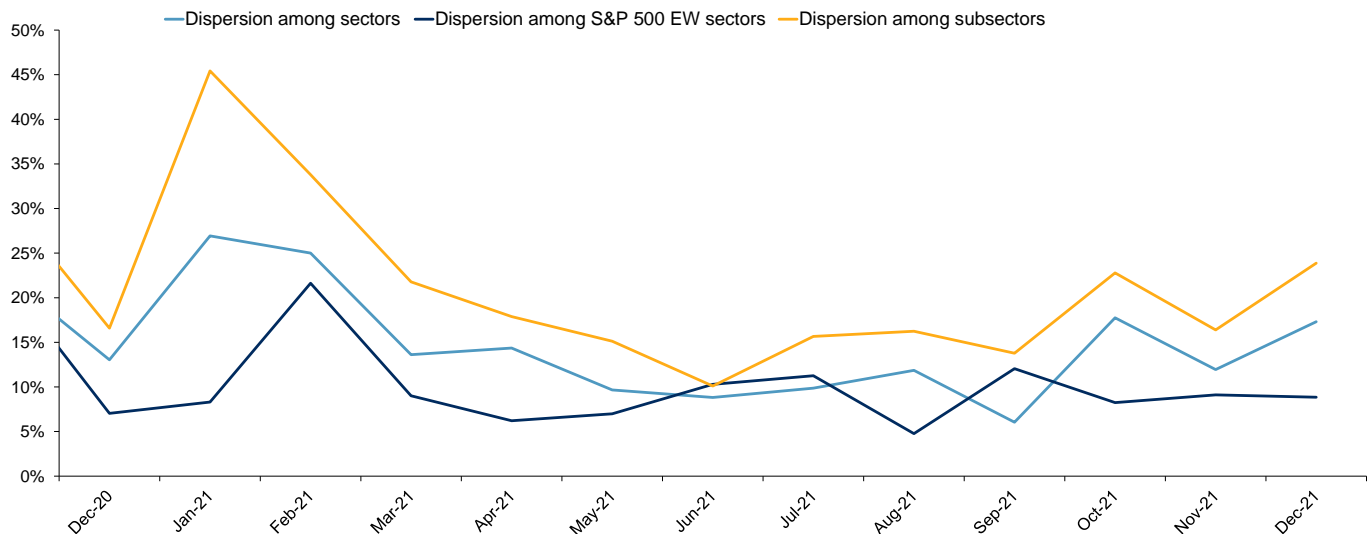
