## **Performance Summary**

- The S&P PRISM ETF Tracker Index posted 1.61% in June, with all three asset classes contributing to the positive performance of the index.
- U.S. equities posted another solid month of returns, in part thanks to a slightly better CPI reading, which showed inflation dropping from 3.4% in April to 3.3% in May. The iShares Core S&P 500® ETF returned 3.26% in June.
- Corporate bond prices moved slightly upward in June, with the iShares iBoxx \$ Investment Grade Corporate Bond ETF returning 0.22%. With falling inflation, investors speculated on the timing of rate cuts by the Federal Reserve, driving the yields of corporate bonds down.
- Commodities as a whole were up in June, with the iShares S&P GSCI Commodity-Indexed Trust returning 0.91%.
   Livestock and energy were the only sectors in the S&P GSCI to post positive performance.
- Similar to last month, weight in equities and bonds increased, while weight in commodities decreased. Total weight in risky assets remained at 75%.
