The S&P Balanced Equity and Bond Index - Growth is designed to allocate a 75% weight in core equity (S&P 500 TR) and a 25% weight in fixed income (S&P U.S. Treasury Bond 7-10 Year Index) to provide a regularly rebalanced multi-asset measure for growth risk/reward profiles.

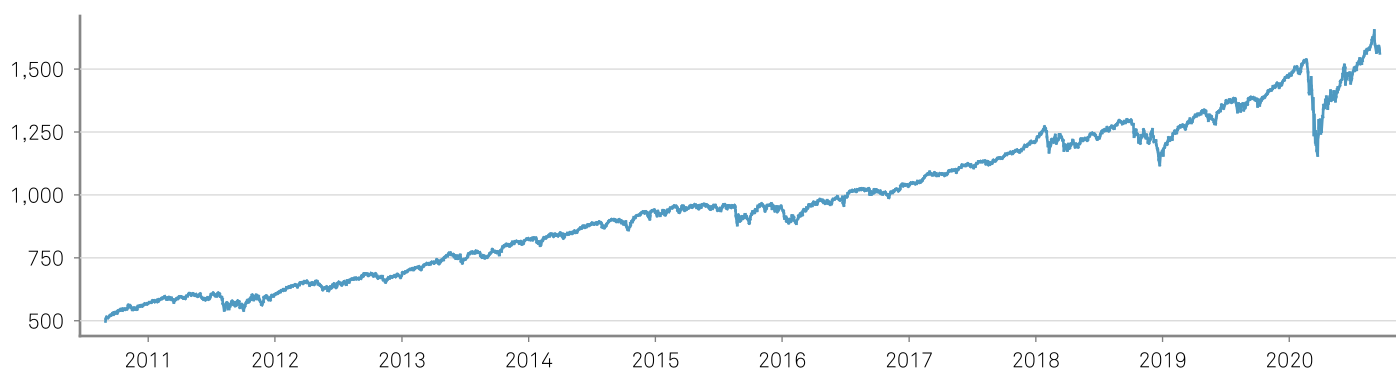
